INTRODUCTION

Securing the effective right to privacy with respect to the gathering and processing of personal data has become a key challenge of our time. The 7th International Media Law Forum (IMLF) addresses this in regard to the practice and regulation of media and Internet companies. Why is the US stance on data protection so more liberal? What implications have the different protection levels for an effective European data protection? What is the role of the German “Grundgesetz” in such an international environment the Internet provides? What implications will the “right to be forgotten” have that the European Court of Justice backed in its decision issued on 13th May 2014 so that individuals have a right to control their data and that they can ask search engines to remove results? These questions are huge. But how we answer them deeply influences the future and freedom of the Internet as whole.

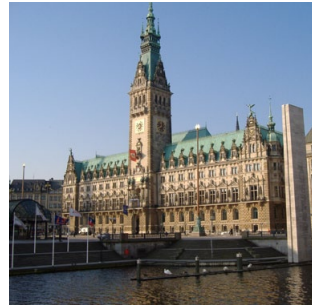

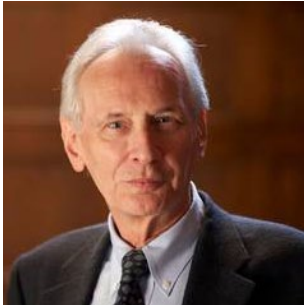

Professor Dr. Dr. h.c. mult. Dieter Grimm, LL.M. (Harvard) is a Professor of Law at Humboldt University of Berlin and a Visiting Professor of Law at Yale Law School. He is also a Permanent Fellow and former Director of the Wissenschaftskolleg zu Berlin. From 1987 until 1999, he served as a Justice on the Federal Constitutional Court of Germany. An honorary member of the American Academy of Arts and Sciences, he holds law degrees from the University of Frankfurt (Dr. iur. 1971 and “Habilitation” 1979) and a Master of Laws from Harvard (1965). His recent publications include “Der Datenschutz vor einer Neuorientierung” (JZ 2013, 585) and “Die Zukunft der Verfassung, Band II – Auswirkungen von Europäisierung und Globalisierung” (Suhrkamp 2013).

Professor Daniel Markovits is Guido Calabresi Professor of Law at Yale Law. After earning a B.A. in Mathematics from Yale University (1991), Markovits received a British Marshall Scholarship to study in England, where he was awarded an M.Sc. in Econometrics and Mathematical Economics from the London School of Economics (1992) and a B.Phil. and D.Phil. in Philosophy from the University of Oxford (1994/1999). Markovits then returned to Yale to study law and, after clerking for the Honorable Guido Calabresi, joined the faculty at Yale.

Professor Dr. Hannes Rösler, LL.M. (Harvard) is a Professor for Civil Law, International Private Law and Comparative Law at the University of Siegen. From 2004 to 2013 he was a senior researcher at the Max Planck Institute for Comparative and International Private Law in Hamburg. Rösler concluded his “Habilitation” at the University of Hamburg in 2012. He attended law school in Marburg (Dr. iur. 2003), as well as the London School of Economics and Harvard University (LL.M. 2004). Before being a professor in Siegen, he has held interim professorships at the Universities of Freiburg, Bonn and Frankfurt (Oder). Rösler has an extensive list of publications to his credit including articles on privacy and the media. He has founded the IMLF in 2008 together with Dr. Daniel Biene.
